- Review and define test cases, test architecture for testing, and requirements around a test suite for an initial Plugfest.
- Define initial test materials and test cases for ratification by the Technical Committee and approval by the Board of Directors.
- Discuss and define the parameters of the test suite development process, , role of this Project Group in connection with the other Project Groups who are interested in testing.
- Possible liaison relationship with external entities regarding testing and test plans or complimentary testing programs.
- Discuss and define use cases or other informative documents to extend plugfest event to additional domains (RAN, Core, access excluding RAN, transport) and functional area (interoperability, performance, security, stability and scalability) of telecom infrastructure.

#### 4. PROJECT GROUP DELIVERABLES

- Test documents and test materials for testing telecom infrastructure over different domains (RAN, Access, Transport, Core) and different functional area (InterOp, Performance, Scalability and Stability, Security).
- White papers summarizing the testing environment, and other information related to testing products in the TIP ecosystem.
